### Message from the SG

In 2023, conflicts and emerging crisis across the globe placed people at even greater risk of torture and ill-treatment. To respond to ongoing and future challenges, strengthening our anti-torture community is key. This annual report showcases the results of many of our joint efforts, based on our Strategic Plan. Here are three major achievements.

First, the International Conference of National Human Rights Institutions adopted the Kyiv-Copenhagen Declaration, which reaffirms the crucial role of NHRIs in the fight against torture and ill-treatment. With more than 80 NHRIs signing on, this is an important milestone that underlines the importance of prevention, transparency and safeguards.

Second, the APT joined forces with five other anti-torture organisations to form the United Against Torture Consortium. With our joint expertise — in prevention and rehabilitation, justice and accountability — we support partners globally to grow the movement for a torture-free world.

Third, there is new dynamism for OPCAT implementation in Africa, with two regional conferences by the UN Office of the High Commissioner for Human Rights, supported by APT, as well as the creation of an NPM regional network.

This annual report highlights many more APT initiatives at the international, regional and national levels, all of which help strengthen the torture prevention community. Thank you to all our partners and donors for contributing to societies without torture or ill-treatment.

### People are treated with dignity and fairness by the criminal justice system

### Arrest, interrogation and police custody are all moments of increased risks of torture and ill-treatment.

In 2023, we continued to promote the use of the Méndez Principles on Effective Interviewing as a constructive framework to replace coercive interrogation with rapport-based interviewing. In Thailand, the entry into force of the new anti-torture law in February 2023 created new momentum for our work with police. Worldwide, we continued to focus on implementation of safeguards in the first hours of detention. In Brazil, we trained judges in two states and published

nationwide data on how judges implement safeguards and conduct custody hearings. In Madagascar, the letter of rights and registers in police custody, which we helped develop, are used in police stations across the country and the implementation manual has been translated into Malagasy. We have promoted transparency and oversight of police custody by NPMs and NHRIs, including with our #SafeinCustody project partners in Thailand, Malaysia and the Philippines.

### **BRAZIL. OBSERVA CUSTÓDIA DATABASE**

We further developed our public database on custody hearings, launched in 2022 with 14 Brazilian civil society and public defenders organisations. We published a second round of data in August, collected from 71 courts from all 27 Brazilian states spreading beyond the capital cities, to support comparative analysis of progress and gaps over the previous year.

### THAILAND, MÉNDEZ PRINCIPLES

In Thailand, our work to support integration of the Méndez Principles in the training of police cadets gained new ground. Following a training workshop for the Royal Police Cadet Academy (RPCA) in May 2023 alongside the Norwegian Center for Human Rights, RCPA lecturers began research on current interviewing practices in Thai police investigations and a project to integrate the Méndez Principles in the RCPA curricula.

### MÉNDEZ PRINCIPLES: INTERNATIONAL SUPPORT AND OWNERSHIP BY PARTNERS

The UN Human Rights Committee recommended to eleven States reviewed in 2023, including Brazil, to integrate the Méndez Principles in their training to law enforcement officials, members of the judiciary, prosecutors and prison staff. Partners translated the Principles into Bosnian/Croatian/Serbian, Indonesian, Latvian, and Turkish. In Thailand, the Nitivajrat Institute printed 5,000 copies of the Méndez Principles in Thai to train prosecutors

## Persons in situations of vulnerability are safe from torture and ill-treatment



Deprivation of liberty disproportionately affects people who suffer from conditions of inequality, including structural and intersectional discrimination.



In 2023, we continued promoting a differentiated approach to respond to the specific needs of persons in situations of vulnerability deprived of liberty. We supported independent oversight mechanisms and judicial actors to address the risks of discrimination, abuse and torture faced by women and LGBTIQ+ persons in police custody and prison. Responding to the increasing need to address mental health in detention, we fostered exchanges of experiences between NPMs, civil society organisations and international experts to better prevent ill-treatment and torture of persons with mental health conditions in different detention settings.

### BRAZIL: LANDMARK REPORT ON LGBTIQ+ PERSONS DEPRIVED OF LIBERTY

In September 2023, the NPM of Brazil, LGBTIQ+ organisation SOMOS, and local preventive mechanisms of the states of Rondônia and Pernambuco launched the first <u>national report</u> by torture prevention mechanisms dedicated to the treatment and conditions of detention of LGBTIQ+ persons deprived of liberty. The report includes data from visits to 24 detention centres in 12 states of Brazil.





### MONITORING MENTAL HEALTH IN DETENTION

The APT, in partnership with the Council of Europe (CoE), OSCE/ODIHR and the Danish Parliamentary Ombudsman, facilitated face-to-face dialogue between independent oversight bodies from over 30 countries in Europe and Central Asia, civil society and international experts. They identified strategies to address the challenges and risks faced by people with mental health conditions in prisons, pre-trial detention, psychiatric institutions, social care facilities and immigration detention. A joint APT/CoE webinar also addressed this issue earlier in 2023.

# Strong arguments and new voices are mobilised to prevent torture



Powerful synergies and new voices are vital to raise awareness and build engagement in support of torture prevention.



In 2023, together with our partners, we continued to reach out to the public, especially youth, through a music festival, speech competition, fun run and other events. On 26 June, International Day in Support of Victims of Torture, we mobilised public support for the absolute prohibition of torture. We featured photographs by our colleague Ben Buckland on social media and in photo essays to present torture prevention efforts through a fresh lens. And with the launch of our new website, we improved access to APT resources, videos, podcasts and in-country activities.

#### UNITED AGAINST TORTURE CONSORTIUM

We are stronger together and when we speak with one voice. This year, we joined five leading anti-torture organisations to launch a new consortium, United Against Torture, funded by the European Union. We are partnering with the World Organisation Against Torture (OMCT), International Rehabilitation Council for Torture Victims (IRCT), International Federation of Action by Christians for the Abolition of Torture (FIACAT), Omega Research Foundation and REDRES. Building on our different areas of expertise, from prevention to rehabilitation, litigation and accountability, we will support and grow the global movement against torture.

### **#SAFEINCUSTODY FESTIVAL**AND SPEECH COMPETITION

We recognise the importance of young people as agents of change for torture prevention. Through the #SafeinCustody project, our partner Suara Rakyat Malaysia (SUARAM) organised a creative festival in Kuala Lumpur, Malaysia. With speeches, presentations, music and theatre performances, more than 300 young people took part in a conversation about their rights during police arrest and custody.

Together with our national partners in Malaysia, Philippines and Thailand, we held the first-ever #SafeinCustody Speech Competition to inspire new voices and future advocates. More than 30 students from the three countries delivered speeches on anti-torture themes.

### Effective and independent oversight protects persons deprived of liberty





### We continued to promote OPCAT implementation in many countries through bilateral support to National Preventive Mechanisms and regional exchanges.

We responded to many requests from NPMs and conducted capacity strengthening workshops with the NPMs of Cabo Verde, Madagascar, Maldives, Panama and Togo. Ahead of visits by the SPT to South Africa, Madagascar and the Philippines, we held in-country preparation meetings with civil society organisations and the NPM. We also commented on draft Bills to establish NPMs in the Philippines. South Africa and Côte d'Ivoire. At the regional level, the APT supported and

participated in two conferences in Africa on the OPCAT, along with the launch of the network of African NPMs in Morocco. We also organised a regional workshop with NPMs in Latin America and for NPMs in the OSCE region, where new NPMs from Mongolia and Slovakia participated for the first time. In addition, we launched an online course on the OPCAT and contributed significantly to the outcome declaration adopted at the 14th International Conference of NHRIs, held in Copenhagen.



The APT brought us together bilaterally and collectively with NPMs internationally and regionally in ways that enrich our work. Their less visible role as a confidential and impartial 'friend of the institution' is particularly useful as we navigate the numerous political and policy challenges we face in our daily work.

### ADVANCING OPCAT IMPLEMENTATION IN AFRICA

With 24 States Parties, Africa is the second largest region for OPCAT ratification. 2023 saw the region take a step forward in implementing the OPCAT, through the establishment and operation of NPMs. Two sub-regional conferences organised by OHCHR with the support of APT provided new momentum, with Cote d'Ivoire ratifying OPCAT and Burkina Faso launching its NPM. Developments are also under way in Gabon and Benin. A total of 14 NPMs are now operational and an Africa-wide NPM network was established in June 2023.

### NHRIS REAFFIRM THEIR ROLE TO PREVENT TORTURE

The role of NHRIs to combat and prevent torture and other ill-treatment was the theme of the 14th International Conference of NHRIs, held in November 2023. The APT supported Global Alliance of NHRIs in organising the conference, which adopted a milestone Declaration that highlights the vital role of NHRIs to prevent torture, including when they are designated as NPMs, and sets out areas for future work and collaboration.



### BRAZIL: IMPLEMENTING THE OPCAT SYSTEM

Brazil was before the UN Committee against Torture (CAT) for a landmark review following a 25-year gap. The CAT called on Brazil to promptly establish a network of fully-resourced and independent local preventive mechanisms (LPMs) in all states, a measure also advocated by the APT. This led to new momentum at national level. An LPM was established in the state of Acre, the sixth in the country and two other states are making significant progress towards this end. The APT supported these processes, providing training for the new LPM in Acre and participating in regular meetings of the National Committee to Prevent Torture.

### **Equipping detention monitors**



Torture prevention requires specific skills and knowledge, especially detention monitoring activities.

The APT's online platform — the Torture Prevention Learning Village — was further enhanced this year to meet these needs: with a new course on the OPCAT; improved chat features in the Virtual Café; and in-depth courses for oversight bodies and institutions to strengthen their capacity.

#### **OPEN COURSES AND IN-DEPTH LEARNING**

We launched an open course (in English, French and Spanish) that introduces and explores key elements of the OPCAT. We also developed in-depth courses that provide advanced knowledge on: gender-sensitive detention monitoring, including preparing reports and recommendations; the role of NHRIs in torture prevention; and monitoring police custody. Representatives of the judiciary, police, NHRIs and NPMs from five countries (Brazil, Cabo Verde, Maldives, Morocco and the Philippines) took part in these courses.

### VIRTUAL CAFÉ FOR BLENDED LEARNING AND COMMUNITY BUILDING

The Virtual café allows participants from across the globe to discuss common issues, ask questions and share experiences related to torture prevention. This has been useful in strengthening our online community of practice.

We honour our friend and former colleague, Jean-Baptiste, who passed away on 2 November 2023. As APT Africa Programme Officer for 20 years, Jean-Baptiste was a tireless ambassador for torture prevention on the continent, respected by all. With others, he helped establish the 2002 Robben Island Guidelines for the Prohibition and Prevention of Torture in Africa. We miss him deeply but his legacy remains.
